Innovative and creative services in the community.

Giles Health and Family Center is small non-profit organization in rural Giles County, Virginia. They rely on a variety of grants and cooperative agreements with community partner organizations and local governments for funding and resources. GHFC also works with Medicaid Brokers to provide transportation to their client base. Partnerships with our local hospital, county government and other nonprofits allow us to serve more people on a variety of levels. Not only do we provide non-emergency transportation, Giles Health and Family also provides adult day care services as well as Early Head Start and public based childcare. Certified staff also provides outreach services, such as American Red Cross CPR/First Aid/AED training, Mental Health First Aid training, and serves as resources to accessing community-based assistance programs. Recently, GHFC has partnered with the local NRV Regional Commission and County Administration to support recovery through Opioid Abetment funding. This partnership will allow provide transportation for employment, quality of life needs and accessing other programs and needs of those re-entering society.

Q10

Being responsive to its customers' and community needs.

The above-mentioned services play an integral role in addressing community needs. Public transit is not currently available in Giles County. Many clients are also disabled and need wheelchair or stretcher transportation. GHFC offers curb to curb, door to door and hand to hand assistance for those who need a higher care level in regard to transportation. Uber and private taxi modes of transportation are also not a realistic option, because of high cost associated with dead head, distance and terrain associated with a rural area. GHFC recognizes this need and provides low-cost transportation to the citizens of Giles County. Giles County also serves a high population base of those on Social Services assistance. Partnering with the Virginia Transit Association, GHFC is assisting TANF recipients to provide transportation to access employment, quality of life and childcare services. We partner with our local social services for parental visitation and counseling trips for clients and have contracts with area nursing homes, rehab facilities and hospitals for discharges.

Actively coordinating and collaborating with other public and special services transportation.

We have existing partnership with our local Agency on Agency, Department of Social Services, Women's Resource Center, homeless assistance organizations and veterans' services groups. We are working with our county's drug recovery program in assisting those affective by drug use who are re-entering society.

Effectively helps the community accomplish their goals.

With the need for public transportation, we work to fill the void for members of the community not only with non-emergency transportation but also with life enhancing trips as well. We take community members to work, school, daycare, grocery store, hair salon, church services and other life enhancing needs. We believe everyone should have access to transportation and do our best to fulfill every request. This is often at a financial cost to our organization because public transportation is not currently offered in Giles County. GHFC has recently partnered with Giles County Administration officials and DRPT to conduct a public transit needs assessment.

Each year we apply for the DRPT 5310 grants to replace the highest mileage vans in our fleet. We take great pride in our reputation and the service we provide to our community members.
