Giles Health and Family Center is a small non-profit organization that recently celebrated its 20th year of serving the residents of Giles County, Virginia. As a small non-profit organization. Partnerships with our local hospital, county government and other nonprofits allow us to serve more people on a variety of level. Not only do we provide non-emergency transportation, our organization also provides adult day care services as well as Early Head Start and child care. Staff also certify individuals in American Red Cross CPR/First Aid/AED training as well as Mental Health First Aid for youth and adults. Staff also participate in numerous community minded outreach programs such as Directors Forums, various state and local community service based associations. Memberships to various organizations also play an important role in our staffs job duties.

GHFC is a recipient of a state TANF grant that allows parents who meet certain criteria to access free transportation to and from work. We partner with our local social services for parental visitation and counseling trips for clients and have contracts with area nursing homes, rehab facilities and hospitals for discharges.

We have existing partnerships with our local Agency on Agency, department of social services, women's resource center and homeless assistance organizations and veterans services groups. We also work with our county drug recovery program. With the need for public transportation, we work to fill the void for members of the community not only with non-emergency transportation but also with life enhancing trips as well. We take community members work, school, daycare, grocery store trips, hair salon, faith based services and other quality of life needs. We believe everyone should have access to transportation and do our best to fulfill every request. Giles County, in partnership with GHFC, recently conducted a public transportation needs assessment through the Virginia Department of Rail and Transportation. On Demand Service, would be the only viable solution for public transportation for our rural community. Until a public transit system is established, Giles Health and Family Center serves the community in this capacity.

GHFC has a vast network of partnerships in and around our community.

NRV Community Services, Giles Social Services, Giles Social Services, Giles County Government, NRV Agency on Aging, Carilion Hospital Med Surge, NRV Disability Resource Center Country View Nursing Home, Heritage Hall Nursing Home Rich Creek and Blacksburg, Pulaski Health and Rehab Radford Health and Rehab, Highland Ridge Rehab, Feeding America of Southwest Virginia, New River Community College.

Among our fleet of vehicles, 11 are full handicap vans, one is a stretcher (ambulance) and two are multi-passenger transit vans. These vehicles allow us to meet a wide range of client needs. We take great pride in our reputation and the service we provide to our community members.
