

RELEASE OF LIABILITY AND ASSUMPTION OF RISK

The individual named below (referred to as “I” or “me”) desires to participate in The National Community Transportation Roadeo in Ohama, Nebraska on May 10-13, 2026 (the “Activity”), during the 2026 EXPO of the Community Transportation Association of America (“CTAA”), located at 1341 G St NW #210, Washington, DC 20005. In consideration of the intangible value that I will gain by participating in the Roadeo and in recognition of CTAA’s reliance hereon, I agree to all the terms and conditions set forth in this instrument (this “Release”).

1. Assumption of Risk

I understand and acknowledge that the Activity I want to participate in may be dangerous and may involve the risk that I will sustain serious injury, temporary or permanent disability and/or death. I understand that the Activity may not be fully supervised and that the CTAA does not provide medical services, although Emergency Medical Technicians will be present during the event. I further acknowledge that any injury I may sustain while participating in the Activity may be compounded by negligent or delayed medical service or negligent or delayed assistance by the CTAA. I VOLUNTARILY AND FREELY ASSUME ALL RISKS AND DANGERS THAT MAY OCCUR PURSUANT TO MY PARTICIPATION, INCLUDING THE RISK OF INJURY, DEATH, OR PROPERTY DAMAGE, EVEN IF CAUSED BY NEGLIGENCE, ACTIONS, OR OMISSIONS OF CTAA.

2. Release from Liability

I hereby agree, on behalf of myself, my heirs and my personal representatives, to fully and forever discharge and release CTAA and its officers, directors, employees, agents, members, successors, and assigns (“Released Parties”) from any and all claims I may have or hereinafter have for any injury, temporary or permanent disability, death, damages, liabilities, expenses and/or causes of action, attributable or relating in any manner to my participation in the Activity. I acknowledge and agree that this Release is intended to, and is, a complete release, as much as allowed by law, of any

responsibility of the Released Parties for all personal injuries, temporary or permanent disability, death, and/or property damage sustained by me while participating in the Activity.

3. Covenant Not to Sue

I hereby agree, on behalf of myself, my heirs and my personal representatives, not to sue the Released Parties or initiate or assist in the prosecution of any claim for damages or cause of action against the Released Parties which I or my heirs or my personal representatives may have as a result of personal injuries, temporary or permanent disability, death, and/or property damage sustained by me while participating in the Activity.

4. Indemnification

I hereby agree to defend, indemnify and hold harmless CTAA and the Released Parties from and against any third-party losses, damages, actions, suits, claims, judgments, settlements, awards, interest, penalties, expenses (including reasonable attorneys' fees) and costs of any kind for any personal injuries, temporary or permanent disability, death, and/or property damage sustained by reason of or arising out of my participation in the Activity.

5. Medical Treatment Release

I hereby authorize the CTAA to secure, and I consent to, any medical treatment that may be given to me should the CTAA determine, in its sole discretion, that I need medical care, as a result of my participating in the Activity. I accept full responsibility for all costs related to my medical treatment, including any transport costs, and I release all parties involved from any type of liability for anything that may happen during my treatment or transport.

6. Photo/Video Release. I give CTAA the right and license to photograph, record, or video me, and to edit, use, and reproduce my image, performance, and physical likeness (including negatives, finished pictures, proofs, transparencies, copies of the original prints and negatives, and reproductions), as well as my personal information, including my name and biographical information,

in whole or in part, in print or electronically, for any lawful purpose, on a perpetual and worldwide basis.

7. No Representations by CTAA

I acknowledge that although the Roadeo Committee will perform an industry standard pre trip inspection on all vehicles being used in the activity, CTAA makes no representation as to the condition of the premises where the Activity is held, or the safety of the Activity or any equipment either at the premises or used in the Activity. I accept and shall use the premises, and its equipment, in its “AS IS” condition. I acknowledge and agree that I am not relying upon any representation or statement by the CTAA or the CTAA’s employees, agents, sponsors, or representatives regarding this agreement or the premises or Activity, except to the extent such representations are expressly set forth in this agreement.

I HEREBY ACKNOWLEDGE THAT I HAVE FULLY READ AND UNDERSTAND EACH OF THE ABOVE PROVISIONS AND THAT I UNDERSTAND I AM GIVING UP SIGNIFICANT LEGAL RIGHTS OF MINE, INCLUDING THE RIGHT TO SUE THE CTAA. I ACKNOWLEDGE THAT PRIOR TO SIGNING THIS AGREEMENT I AM AT LEAST EIGHTEEN (18) YEARS OF AGE AND FULLY COMPETENT, AND I EXECUTE THIS AGREEMENT VOLUNTARILY AND FOR ADEQUATE CONSIDERATION INTENDING TO BE FULLY BOUND.
